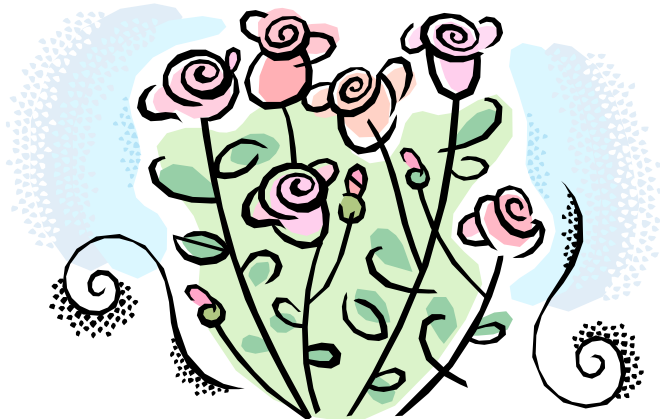

Directions:

From Stamford area: (@ 67 miles - 90 minutes)

I-95 North to Exit 27A to Route 8 North, to I-84 East, to Exit 31, Rte 229 (West Street), take a left off exit ramp onto Route 229, go past ESPN, turn left onto Enterprise Drive then right onto Century Drive.

From Hartford area: (@ 19 miles – 30 minutes)

I-84 West: Take Exit 31, Rte 229 (West Street), take right off exit ramp onto Route 229, go past ESPN, left onto Enterprise Drive then right onto Century Drive.

From Danbury: (@43 miles- 55 minutes)

I-84 East: Take Exit 31, Rte 229 (West Street), take left off ramp onto Route 229, go past ESPN, left onto Enterprise Drive then right onto Century Drive.

From Shore Area:

Take Route 9 N to Rte 72 W to I-84 W - Take exit 31, Rte 229 (West Street), take right off exit ramp onto Route 229, go past ESPN, take a left onto Enterprise Drive then right onto Century Drive.

Or

Take 91 N to 691 W to I-84 E. Take Exit 31, Route 229 (West Street), take left off ramp onto Route 229, go past ESPN, take a left onto Enterprise Drive then right onto Century Drive.
